### \*\*\*GUIDELINES\*\*\*

1. To be eligible for the awards, the nominated person must be working or volunteering on a regular basis with senior adults or in the senior healthcare industry. Attached you will find the list of award categories.
2. The winners will be announced at the Caregiver Awards on April 16<sup>th</sup>, 2009. The Caregiver Award winner will receive an award and other gifts.
3. All nominators must fill out this form and attach an essay describing why this nominee deserves the award.  
**NOTE: Parts of the essay will be read at the event if your nominee is a category winner.**
4. All nominations must be received by **March 15<sup>th</sup>, 2009**.
5. Once the nomination has been received, you will be mailed/emailed a confirmation of receipt of the nomination. It is your responsibility to notify the person you nominated about the nomination and about attending the event. If you have not received a confirmation two weeks prior to the event (by April 1<sup>st</sup>, 2009) it is your responsibility to notify us immediately. Please keep copies of all nomination materials.

## TWELVE AWARD CATEGORIES

### **Assisted Living Caregiver of the Year**

Nominees for this award work in a retirement community giving day to day assistance to residents of that community. This can be at a Continuing Care Retirement Center, an Assisted Living Center, Alzheimer's Center or an Adult Day Care. Any workers at that center are eligible for this award whether they are caregivers, maintenance workers, housekeepers, activity workers, security attendants, nursing assistants, dietary workers, receptionists, etc.

### **Hospice Caregiver of the Year**

Nominees for this award work in a hospice environment whether they serve people in their homes, retirement centers or in a hospice house. Any workers for a hospice agency are eligible for this award whether they are in the direct line of service or not. This includes but is not limited to case managers, nurses, attendants, receptionists, etc.

### **Home Health Caregiver of the Year**

Nominees for this award work for a home health agency that provides medical services to seniors in their own homes or retirement centers. Any workers at a home health agency are eligible for this award whether they are in the direct line of service or not. This includes but is not limited to nurses, physicians, attendants, therapists, social workers, home managers, receptionists, etc.

### **Skilled Nursing Caregiver of the Year**

Nominees for this award must work in a skilled nursing environment whether that is in a stand alone skilled nursing facility or in a skilled center attached to a continuing care retirement center. Any workers at a skilled nursing facility are eligible for this award. This includes but is not limited to nurses, certified nursing assistants, housekeepers, maintenance workers, activity workers, case managers, receptionists, therapists, etc.

### **Home Care Caregiver of the Year**

Nominees for this award must work for a non-medical home health agency. All workers at a non-medical home health agency are eligible for this award. This includes but is not limited to attendants, caregivers, case managers, etc.

### **Case Manager of the Year**

Nominees for this award must work in the role of a case manager either independently or for an institution serving the senior population. This includes but is not limited to hospitals, skilled nursing facilities, medical offices, home health agencies, state funded service organizations, non-for-profit service agencies, etc.



## AWARD CATEGORIES CONTINUED...

### **Administrator of the Year**

Nominees for this award must work in the role of an administrator for an institution serving the senior population. This includes but is not limited to hospitals, continuing care retirement communities, assisted living facilities, skilled nursing facilities, medical offices, home health agencies, support agencies, etc.

### **Medical & Rehabilitation Service Representative of the Year**

Nominees for this award must work for any type of medical service provider or supplier that works directly with seniors. Examples include rehabilitation providers, medical equipment companies, hearing and vision companies, etc. This includes but is not limited to rehabilitation specialists, sales representatives, technicians, delivery personnel, store managers, etc.

### **Senior Service Professional of the Year**

Nominees for this award must work for an agency providing services to senior adults outside of the realm of direct care or medical care or be self-employed in said field. These agencies include but are not limited to long term care insurance providers, federal agencies such as Medicare or Veteran's Assistance, AARP, senior centers, elder law attorneys and professionals, housing authority, disability services, transportation assistance, senior real estate specialists, mortgage specialists, financial planners, agencies on aging, social security, etc.

### **Marketing and Sales Representative of the Year**

Nominees for this award must work in a sales position for a company that serves senior adults or be self-employed in said field. This includes but is not limited to marketing personnel for retirement centers, media representatives, home health representatives, equipment sales, insurance sales, food supply sales, etc.

### **Family Caregiver of the Year**

Nominees for this award must be a family member, neighbor or friend of a family that is taking/has taken care of a family member (mother, father, aunt, grandfather, etc.) in their home or in the senior's home giving them the best quality of life outside of a senior center or retirement facility. This could be a paid or unpaid arrangement.

### **Senior Service Volunteer of the Year**

Nominees for this award must be a volunteer in a role that supports seniors whether directly or indirectly. This includes volunteers that work for for-profit and not-for-profit agencies, as well as individuals that volunteer for families or churches in the support of seniors. Any volunteers are eligible as long as no payments are received for their services.
